





THE "TOGETHER WE CAN" CAMPAIGN

Monument Health Foundation surpassed \$8.5 million Together We Can capital campaign goal to support the Cancer Care Institute expansion. More than \$2 million was received from 1,100 donors in four months.

Residents across the Black Hills will receive state-of-the-art cancer treatment at Monument Health for generations thanks to the generous donations of community members across our region. Monument Health Foundation completed the Together We Can, capital campaign in support of Cancer Care Institute expansion project in April.

Monument Health Foundation announced the \$8.5 million capital campaign in January with a Foundation commitment of \$6.5 million in previously raised funds and a pledge to raise an additional \$2 million.

During a groundbreaking ceremony in April, the Foundation announced they had surpassed this goal. More than 1,100 donors gave to the campaign, said Robin Zebroski, Vice President of Foundation and Brand Strategy.

"It's been so heartwarming to see our community come together and recognize the impact this expansion project will have. Thank you all for helping make this vision a reality," she said. "Every gift makes a difference - contributions big and small have come from patients and caregivers; businesses and foundations. Thank you to every single person that opened their hearts and offered dollars to make our dream a reality."

The two largest donations were from the Dakota Charitable Foundation in honor of Ray Hillenbrand and the Monument Health Rapid City Hospital Auxiliary. The campaign was co-chaired by then-Foundation Board Chair Pat Burchill and Dr. Daniel Petereit.

The expansion project will double the size of the current facility and will enable CCI to improve patient comfort, take a multidisciplinary approach to treatment and provide more high-quality cancer care — close to home. The project is expected to be completed by summer of 2023.

"This project is about making sure cancer care is available close to home for thousands of patients each year," said Paulette Davidson, President and CEO of Monument Health. "A cancer diagnosis upends a person's life like few other things can. I am so proud to know that we are building a place that will allow us to care for more patients here in our local community."

Thank you to all who contributed and helped make this vision a reality to improve how we deliver treatment to cancer patients in the Black Hills.

THE CANCER CARE INSTITUTE HEALING GARDEN

CARING PRACTITIONER BECOMES GRATEFUL PATIENT

WENDY ASHER'S STORY



"I was blindsided by this unexpected diagnosis, and he helped me believe I could do this hard thing."

WENDY, ON THE CARE FROM DR. ERIC EASTMO

WENDY ASHER spent her 40-year career caring for others, first as a nurse, and for the past 20 years as a pediatric nurse practitioner at Monument Health Rapid City Hospital. In the fall of 2020, her colleagues began caring for her.

After an abdominal ultrasound showed masses in Wendy's liver, a series of scans and biopsies revealed tumors scattered throughout her body. Unsure of where to begin, she sent a message to Eric Eastmo, M.D., at Monument Health's Cancer Care Institute asking for an oncologist recommendation.

"I can't think of a better description than this," she said.
"He simply started driving my bus." Dr. Eastmo ordered additional tests and confirmed the diagnosis he suspected: lung cancer with extensive metastatic disease.

Wendy credits Dr. Eastmo with her rapid diagnosis, and especially with providing the support she needed. She said, "I was blindsided by this unexpected diagnosis, and he helped me believe I could do this hard thing."

A week later, Wendy met with Dr. Abdel-Ghani Azzouqa at Monument Health's Cancer Care Institute. "I have worked with literally hundreds of physicians over the past 40 years as a nurse and a nurse practitioner, but I have seldom seen a physician who creates a better experience for patients in a stressful situation," she said.

Treating cancer takes a team, and her entire care team is special to Wendy. She mentioned Oksana Anand, M.D., Valerie Stephens, M.D., Thomas Habbe, M.D., Katie Michelson, CNP, Mary Ann Fredrickson, MSW, nurses, patient navigators and many more. Wendy said that they all provided outstanding care at Monument Health Cancer Care Institute. "Literally every person with whom I have interacted goes above and beyond to make my experience exceptional," she said.

Wendy started cancer treatment in November 2020 with oral medication targeted specifically to her tumor's genetic makeup. Six months into treatment her scans

showed complete therapeutic response: her primary tumor and all metastases were invisible on scans. She knows this isn't permanent and she will continue to have a long road ahead as a cancer patient, but for now she feels well and even took a trip to England this summer to visit her sister.

The amazing care Wendy received moved her to give back.

She sought out Monument Health Foundation to learn more about the "Together We Can" campaign in support of the Cancer Care Institute expansion.

"I decided that I wanted to make a donation to the Together We Can campaign when I received the campaign mailer," Wendy said. "I know that I would not feel as good as I currently feel, and certainly might not be here today, if it were not for this facility and these people."

Wendy's generous donation will go to help build the healing garden just outside the main entrance of the expanded Monument Health Cancer Care Institute.

"Gardens and flowers hold special meaning to me and to my family," she said. "They have always been places of peace, calm and healing for us. I look forward to the creation of such a healing space for cancer patients and their families."

SMALL WONDERS

Monument Health brings miracles to children as a Children's Miracle Network Hospital. But, even small wonders don't come easily. Your donations help provide live-saving equipment to our tiniest patients.

Children's Miracle Network works to fund medical equipment, services and programs for ill and injured children. The hospital's Pediatrics Unit, Neonatal Intensive Care Unit and Advanced Care Pediatrics are the primary areas that benefit from your support.

NICVIEW

Since 2015, the NICVIEW web camera system has been a vital piece of equipment in the Neonatal Intensive Care Unit (NICU) at Rapid City Hospital.

Childbirth is an emotional event for parents and families, particularly when a newborn's first few critical days, weeks or even months are spent in the NICU. Parental joy can be tempered by the unease of separation and the stress of fitting in regular visits.


Bonding between parents and their new baby is as important in the NICU as it is at home. When a baby is cared for in the NICU and can't be together with the parents all the time, bonding can be a challenge. Video streaming with NICVIEW helps families feel more involved right from the start, making them partners in the process of giving their hospitalized infant the best start in life.

The NICVIEW system consists of a simple unobtrusive camera mounted close to baby's bed that delivers streamed video images around the clock, so families can watch their newborn anytime. Livestreaming is only available to specified users, using passwords issued by the NICU staff. NICU staff can post notes in view of the camera to share information about baby's activities. Parents are able to watch over their baby and feel connected even if miles apart. It's the next best thing to being there.

This past year, after six years of providing 24/7 video streaming, the original camera system needed to be replaced with newer equipment and software. Thanks to Children's Miracle Network supporters, along with the Rapid City Hospital Volunteer Auxiliary, the new NICVIEW 2 system was purchased for the NICU, and all 20 cameras were upgraded to

the new technology.

Providing this special equipment ensures that for many years to come parents can be connected and see their newborns receiving the best care possible.

Mediathon is a yearly campaign that benefits the Children's Miracle Network program at Monument Health.



CMN PLAY YELLOW GOLF TOURNAMENT

In September of 2020, the annual Children's Miracle Network Golf Tournament was held at Hart Ranch Golf Club. Taking place outdoors and with many COVID-19 precautions in place, the event saw an increase in participation over the year prior — with 22 teams of four players competing. This meant that more funds were raised, too! The 2020 event raised \$29,945 for Monument Health's Children's Miracle Network program.

The annual golf tournament has been a part of the local CMN program for nearly 30 years. Over the last few years though, CMN's golf event has been branded as Play Yellow. This aligns it with a national initiative that has partnered Jack and Barbara Nicklaus, with PGA TOUR and Children's Miracle Network Hospitals in supporting children at local CMN

hospitals through the golf industry.

Play Yellow stems from the yellow shirts Jack Nicklaus often wore in the final round of tournaments in honor of Craig Smith, the son of a close family friend and who battled rare bone cancer. Craig passed away in 1971 at the age of 13. Fifteen years later, on the morning of the '86 Masters, Jack, at age 46, once again wore a yellow shirt, playing one of golf history's most iconic rounds and winning his record sixth Green Jacket.

Benefiting from **Play Yellow** are the kids that enter our hospitals every day for care. One hundred percent of the proceeds from the event help fund programs, state-of-the-art medical equipment, services for ill and iniured kids and much more.

Thanks to all who sponsored, played, volunteered and helped organize this event.


