ZACHARY'S STORY

An unplanned trip to the hospital with your child is every parent's worst fear. No family plans for their child to get in a car accident or get diagnosed with cancer. Life is fragile and can change in a moment.

When 11-year-old Zachary started to get high fevers, his mom and dad initially treated his fevers with over-the-counter medication. The medicine knocked the fever down a few times, but it kept coming back. This led to the family's first trip to the emergency department. Within 48 hours Zachary was admitted to Custer Hospital for overnight observation and care. When his condition and breathing continued to deteriorate, Zachary was rushed to Rapid City Hospital's Pediatric Intensive Care Unit (PICU). There, he would spend the next couple of weeks fighting for his life.

X-rays and lab tests determined that Zachary had necrotizing pneumonia, a rare and severe complication of bacterial pneumonia that causes the deterioration of lung tissue. Zachary has always been a very healthy kid, so it wasn't clear how he got the infection. But very suddenly, he required specialized care to overcome a life-threatening medical crisis.

"I didn't know at the time that the equipment keeping Zachary alive came from Children's Miracle Network," said Zachary's mom Petra. Children's Miracle Network (CMN) works to fund medical equipment, services and programs for ill and injured children. One hundred percent of CMN funds raised in this community stay local. CMN provides special equipment in the PICU where Zachary received care.

Zachary is healthy now, and life is back to the way it should be for him and his family. The equipment and services from CMN were there for them when they needed it most.

Since opening in 1993, the Regional Health John T. Our largest fundraising effort of the year consisted of Rush Fights Cancer Night, Black Hills Stock Show and Rodeo and the Pink Champagne Brunch. Since 2007, the Foundation has raised nearly \$1.43 million with over \$1 million of that raised during the Black Hills Stock Show and Rodeo! All proceeds go towards purchasing state-of-the-art equipment for Cancer Care Institute patients undergoing treatment.

CCI TEE IT UP FORE CANCER GOLF TOURNAMENT

The 39th Annual Tee It Up Fore Cancer Golf Tournament, held on June 17, 2019 at Arrowhead Country Club, raised over \$60,000. The event included an awards presentation, banquet and auction. Funds raised from the tournament benefit the Cancer Care Institute through the purchase of lifesaving equipment and support to programs that assist cancer patients each and every day, such as the Hand in Healing Fund.

PAINT THE ROCK PINK GOLF EVENT

Paint the Rock Pink is a premier ladies golf event held the second Tuesday of August at the Golf Club at Red Rock. The tournament was created in 2008 as an event to support and celebrate women in the fight against cancer. The \$21,000+ raised at this year's event benefits Image Restoration, which is utilized by patients at the Cancer Care Institute. We are proud to partner with this charity in helping local women in the cancer care recovery process by providing wigs, hats, scarves and post-mastectomy items.

CARLA'S STORY

Care kit fundraiser helps cancer patients cope, recover

For four years, Carla Kapreilian volunteered at the Paint the Rock Pink all-ladies golf tournament to support women in their fight against breast cancer. But in January 2019, the cause became personal. She herself was diagnosed with breast cancer. She was told, “We found something, and it's something serious ... we need to do a biopsy right now.”

Carla flew to a cancer treatment center in Georgia since she has family there. She thought that she would also have her therapy done there as well. However, she says, choosing to have her treatment done in Rapid City was the best decision she ever made. “I felt like a person being treated as opposed to a number being treated. The staff took a personal interest in me, my friends and family. I felt they truly cared about my well-being,” she says.

At her initial appointment following diagnosis and before chemotherapy, she was handed a list of items to help with the side effects of treatment. “Here's the list – it's overwhelming, expensive, uncomfortable, and scary.” Carla wondered how people less fortunate than her could afford to buy all of the products. “They sometimes just don't or can't,” Cancer Care Institute Director Kristi Gylten, told her.

Kristi's words weighed heavy on Carla's heart, so she decided to put a few kits together and donate them. The kits went quickly, and that's when Carla realized how she could help. She wanted to make something fun and uplifting during her journey, so to raise funds for her care kit project, she started a “hair pool.” It's much like a football pool. She sold squares for \$20 each to family and friends from numerous states. Each square represented a prediction about how her hair would grow back – color, length, style, etc. – after chemotherapy. All of the money that she raises goes toward treatment care kits. On November 5th, Carla presented Regional Health Foundation a check for \$8,000 and will begin preparing kits for distribution.

Since Carla started her project, the Cancer Care Institute has started working on a project of its own. Once at the details are finalized, Cancer Care Institute plans to provide a care kit to every new patient receiving radiation or chemotherapy, about 1,500 kits annually. Kristi and Carla have been working together on making sure the proper items go into each care kit.

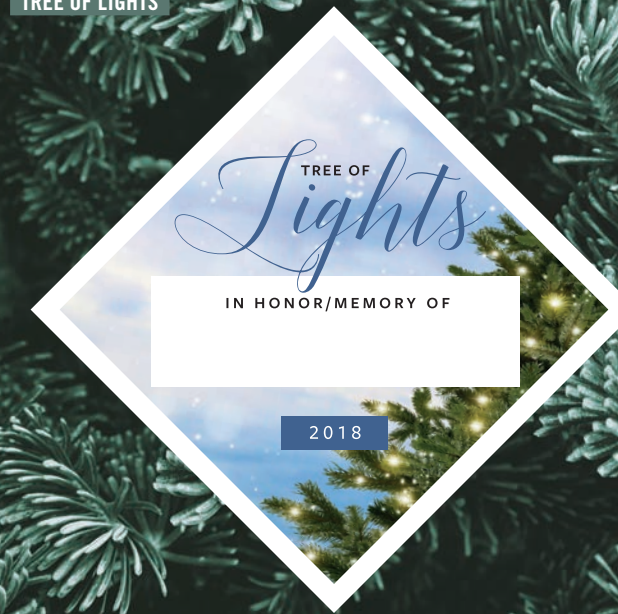


REGIONAL HEALTH HOME+ HOSPICE
